REQUIREMENT OF TECHNICAL ASSOCIATES (RA-I, RA-II, AND RA-III) FOR MIS RELATED WORKS UNDER FSI/NFIS PLAN SCHEME

Forest Survey of India (FSI) is a national organization under the Ministry of Environment & Forests, Government of India and is responsible for forest resource assessment of the country. FSI also takes up National level projects sponsored by the central and state government.

Applications are invited for engagement of Technical Associates (RA-I, RA-II, And RA-III) for MIS related Works Under FSI/NFIS Plan Scheme. The services of TA's will be required initially for a period of one year but their services are likely to be continued further.

Essential Qualification

1. Post Graduate in Science/Environmental Science/Allied subjects along with Ph.D/pursuing Ph.D or M.Tech/ME/MCA or equivalent from a recognized university/institutes
2. Excellent programming skills in Visual Basic (VB), VB.NET, SQL, Crystal Report and Data management in MS SQL Server 2008, MS Access.
3. The requisite experience in database management, software development, MIS, Networking preferably in forestry application must be at least 3 years for RA-I, 4 years for RA-II and 5 years for RA-III. **Attested copy of the experience certificate must be attached.**

Emoluments:

TA (RA-I): consolidated Rs. 22,000/- per month and HRA (as per Govt. Rules)

TA (RA-II): consolidated Rs. 23,000/- per month. and HRA (as per Govt. Rules)

TA (RA-III): consolidated Rs. 24,000/- per month and HRA (as per Govt. Rules)

Touring

Technical Associates (RA-I, RA-II and RA-III) may be required to go on tour for field work etc. for which they will be entitled to TA/ DA as admissible to Junior Technical Assistants of this organization.

Selection Criterion:

Candidates fulfilling the desired qualifications and experience will have to fill up the application form which can be downloaded from our website: www.fsi.nic.in. The duly filled up application form after signature has to be scanned and sent as e-mail attachment to FSI (e-mail: dgfsi@fsi.nic.in). **The scanned copy of the application form along with attested copy of experience certificate should reach to FSI through e-mail by 5.30 pm of 5th September 2014.** The short listed candidates will be intimated over phone and/or e-mail for a selection test which is tentatively scheduled in the **fourth week of September, 2014.** The short listed candidates will have to produce the original application form duly signed and photograph affixed on it on the day of selection test. The candidates have to produce all their original documents on the day of selection test. The selection test may comprise of a written test and/or hands on test and/or interview. Selection will be done on the basis of their qualification, experience and their performance in the written test and/or hands on test and/or interview. Decision of the Director General, FSI will be final. No TA/ DA will be paid for appearing in the test/ interview.

Interested candidates may apply as per the procedure given above. Candidates desirous of applying for more than one position should submit separate application for each position. Application received after due date will not be considered.
