REQUIREMENT OF TECHNICAL ASSOCIATES (RA-I, RA-II, AND RA-III) AND PROJECT SCIENTIST (PS) FOR DIP RELATED WORK UNDER NFIS

Forest Survey of India (FSI) is a national organization under the Ministry of Environment & Forests, Government of India and is responsible for forest resource assessment of the country.

Applications are invited for engagement of Technical Associate (RA-I, RA-II AND RA-III) and Project Scientist (PS) on contractual basis for Digital Image Processing related work under NFIS. The services of TA's and PS will be required initially for a period of one year but their services are likely to be continued further.

Essential Qualification

1. Post Graduate in any science subject or MA in Geography or B.Tech in IT/ CS
2. Candidates other than Post Graduate in Remote Sensing and GIS should have at least ten months' PG diploma course in RS/ GIS from a Recognized Institution.
3. The requisite experience in DIP/ GIS related work in Forestry and other applied areas for different post are as follows:

TA (RA-I): at least five years

TA (RA-II): at least six years

TA (RA-III) & PS: at least seven years

Emoluments:

TA (RA-I): consolidated Rs. 22,000 p.m. and HRA (as per Govt. Rules)

TA (RA-II): consolidated Rs. 23,000 p.m. and HRA (as per Govt. Rules)

TA (RA-III): consolidated Rs. 24,000 p.m. and HRA (as per Govt. Rules)

PS: Rs 15600-39100 plus Grade Pay Rs 5400/-(other allowances as per Govt. Rules)

Touring

Technical Associates and PS may be required to go on tour for field work etc. for which they will be entitled to TA/ DA as admissible to Junior Technical Assistants of this organization. The entitlement of PS will be as per the entitlement corresponding to grade pay.

Selection Criterion:

Candidates fulfilling the desired qualifications and experience will have to fill up the application form which can be downloaded from our website: www.fsi.nic.in. The duly filled up application form after signature has to be scanned and sent as e-mail attachemnet to FSI (e-mail:dgfsi@fsi.nic.in). The scanned copy of the application form should reach to FSI through e-mail by **9th January, 2014**. The short listed candidates will be intimated over phone and/or e-mail for a selection test which is tentatively scheduled on **15th January, 2014**. In case of large number of candidates, selection test may continue on **16th January, 2014** also. If the date of selection is re-scheduled under unavoidable circumstances, the short listed candidates will be intimated through e-mail and/or phone and such notice shall also be displayed at our website: www.fsi.nic.in. The short listed candidates will have to produce the original application form duly signed and photograph affixed on it on the day of selection test. The candidates have to produce all their original documents on the day of selection test. The selection test may comprise of a written test and/or hands on test and/or interview. Selection will be done on the basis of their qualification, experience and their performance in the written test and/or hands on test and/or interview. Decision of the Director General, FSI will be final. No TA/ DA will be paid for appearing in the test/ interview.

Interested candidates may apply as per the procedure given above. Candidates desirous of applying for more than one position should submit separate application for each position. Application received after due date will not be considered.
