Subject: 1) Regarding joining of Sh. Kumar Kalbande in the O/o Regional Director, Regional Office (Eastern), Kolkata.

2) Regarding stopping medical treatment of Sh. Kumar Kalabande by closing his CGHS Card.

With reference to the emails dated 08.12.2023 received from Sh. Kumar Kalbande on the above mentioned subjects, the following point are informed:

- Sh. Kumar Kalbande has been relieved dated 30.07.2021 by the Regional Director, Regional Office (Central), Nagpur and have asked to join Regional Office (Eastern), Kolkata, hence question of handing over charge does not arise. As per records there is no charge lying with Sh. Kumar Kalbande, which has been confirmed by Regional Director, Regional Office (Central), FSI, Nagpur. In case of anything is pending to be done/completed/returned, this will be communicated to the Regional Director, Regional Office (Eastern), FSI, Kolkata, in due course from Regional Director, Regional Office (Central), FSI, Nagpur.
- The LPC has been issued to Regional Office (Eastern), FSI, Kolkata vide letter dated 22.11.2021 and a copy of which was also provided to Sh. Kumar Kalbande in reply to his Public Grievance No. MOEAF/E/2023/0001096 vide letter no. E-484/2019/194 dated 25.05.2023.
- 3. In order to make any payment to Sh. Kumar Kalbande, Sh. Kumar Kalbande needs to be mapped on the PFMS at Regional Office (Eastern), FSI, Kolkata as he was relieved from the Regional Office (Central), FSI, Nagpur. Sh. Kumar Kalbande can be mapped only after joining his place of posting i.e. Regional Office (Eastern) Kolkata. Hence no tour advance, medical payment etc. can be given to Sh. Kumar Kalbande without his joining. Moreover, an advance of Rs. 22,000/is pending with Sh. Kumar Kalbande. Once he joins at his new place of posting all payments due to him will be cleared as per rules.
- 4. In one of the e-mail dated 08th December 2023, addressed to DG FSI, Dehradun, Sh. Kumar Kalbande have stated that he is keen on joining at Kolkata. In another e-mail dated 08th December, addressed to DGF & SS (copy marked to DG FSI) Sh. Kumar Kalbande have written that he wishes to travel to FSI, HQ, Dehradun for redressal of his grievances. Since he has the finances available to travel to FSI, HQ, Dehradun, it is strongly suggested that he may use the same for travelling to Kolkata for joining, he may utilise the same to travel to Kolkata. This way his salary will also start, his pending bills (if any) will get paid and he can draw advances as admissible.
- Regarding application of Section 38 of Disability Act, it is to inform that this office is always ready to provide high support to every disabled employee. It is also informed that vide letter no. 13-15/2022-Admin-Part-1810 dated 01.08.2023, Sh. Kumar Kalbande was asked to appear in the

Govt. Medical College & Hospital for re-examination of his Temporary disability, but it is learnt from Regional Director, Regional Office (Central), FSI, Nagpur that Sh. Kumar Kalbande have not appeared in the Govt. Medical College & Hospital for re-examination.

- 6. No one has stopped Sh. Kumar Kalbande from joining at Regional Office (Eastern), FSI, Kolkata, Even the Regional Director, Regional Office (Eastern), FSI, Kolkata has also recently sent an email regarding this and asking him to join at Kolkata. Hence, Sh. Kumar Kalbande is asked to stop mis-representing things and join at his place of duty.
- 7. Regarding stopping of CGHS, it is to inform that Sh. Kumar Kalbande is unauthorizedly absence from duty since 1/2021. He has been transferred to Regional Office (Eastern), FSI, Kolkata on 30.07.2021, and relieved from Regional Office (Central), FSI, Nagpur on the same day. It is pertinent to mention that CGHS facilities can be availed by the Central government employees on fulfilling the extant criteria and on payment of the prescribed fees. In his case, fees for CGHS card, which is Rs 450/- per month could not be deducted by his offices for almost 03 years (Regional Office (Central), FSI, Nagpur for the period from 1/2021 to 7/2021 and Regional Office (Eastern), FSI, Kolkata from 8/2021 till date) as Sh. Kumar Kalbande is not drawing any salary for being unauthorizedly absent. The CGHS authorities have been informed about his unauthorized absence, non-payment towards CGHS card and his transfer from Regional Office (Central), FSI, Nagpur to Regional Office (Eastern), FSI, Kolkata, his deductions for the CGHS will start again based on which CGHS authorities can be asked for reviving the CGHS card.

This is issued with the approval of the Director General, Forest Survey of India.

Kind reference is invited to the National Human Rights Commission's e-mail dated 04.01.2024 on the above cited subject. Additional/Complete report is as follows:-

 Vide E-mail dated 12.01.2023 from National Human Rights Commission, Action taken report was called for - 27/13/17/2023. In this regard, a detailed report was sent to National Human Rights Commission vide this office letter no. 13-15/2022-Admin-185 dated 09.02.2023, which is as follows:-

Sh. Kumar Kalbande had been serving in Forest Survey of India, Regional Office (Central), Nagpur since 2009, so he was transferred from Regional Office, Nagpur to Regional Office, Kolkata by order No. 7-4/2010-Adm-1224 dated 30.07.2021 along with 4 other employees i.e. 2 Senior Technical Assistants and 2 Junior Technical Assistants in public interest. It is pertinent to note that since his transfer order he has not joined at Forest Survey of India, Regional Office (Eastern), Kolkata office till today.

Sh. Kumar Kalbande has submitted a medical reimbursement claim for his Covid hospitalization which could not be paid by Forest Survey of India, Regional Office (Central), Nagpur office due to paucity of funds. As Sh. Kumar Kalbande was transferred from Forest Survey of India, Regional Office (Central), Nagpur on 30.07.2021 and his Last Pay Certificate was also sent to Forest Survey of India. Regional Office (Eastern), Kolkata. His medical claim for Covid hospitalization for the period from 17.12.2020 to 01.04.2021 was also forwarded to his current place of posting i.e. Forest Survey of India, Regional Office (Eastern), Kolkata. He has already been intimated by the office of the Director General, Forest Survey of India, Dehradun that his pending claims can be settled only after he joins duty in the new office, Forest Survey of India, Regional Office (Eastern), Kolkata.

In support of the claim of temporary disability made by Sh. Kumar Kalbande, this matter has been referred to his current employer Forest Survey of India, Regional Office (Eastern), Kolkata for submission of proper application, medical certificate and other relevant documents. After receipt of the documents, his case will be considered as per the extant rules. Further, three charge sheets have been issued to Sh. Kumar Kalbande for the following charges and the inquiries are going on:-

Complaint of Sexual Harassment of Women at Workplace.

 Securing job in Forest Survey of India, Regional Office (Central), Nagpur with fake experience certificate signed by his father who was working in the Forest Department of Government of Maharashtra.

iii) Unauthorized absence from duty.

The detailed report received in this regard from Forest Survey of India, Regional Office (Central), Nagpur vide letter no E-484/2019/940 dated 23.01.2023 was also attached with the letter. (The entire report is enclosed again as Annexure-I)

- Vide E-mail dated 01.05.2023 from National Human Rights Commission, Additional information was called for - 27/13/17/2023. In this regard, a detailed report vide email dated 06.06.2023 was sent to National Human Rights Commission (copy of email and report is enclosed as Annexure-II).
- Vide E-mail dated 04.01.2024 from National Human Rights Commission, once again Additional/complete information was called for Case no.- 27/13/17/2023

In this regard, Point wise information is as follows:-

(i) Regarding joining of Sh. Kumar Kalbande at Regional Office (Eastern), Kolkata:-

Sh. Kumar Kalbande was transferred from Regional Office (Central), Nagpur to Regional Office (Eastern), Kolkata by order No. 7-4/2010-Adm-1224 dated 30.07.2021. Director General, Forest Survey of India and Regional Director, Regional Office (Eastern), Kolkata have directed to Sh. Kumar Kalbande to join his new place of posting i.e. Regional Office (Eastern), Kolkata many a times and it was also informed to him that after joining, his medical claim would be settled as per Government of India Rules. It is pertinent to note that since his transfer order he has not joined at Forest Survey of India, Regional Office (Eastern), Kolkata office till today.

Against the transfer orders, Sh. Kumar Kalbande moved to Hon'ble Bombay High Court, Bench Nagpur and filed Writ Petition No. 3967/2021. In this case the Hon'ble Court has upheld the transfer order of Director General, Forest Survey of India and has quashed the petition and issued strictures that his behavior is unbecoming of Government servant for his various acts. The excerpts from the judgement of the Hon'ble High Court are reproduced below: -

"The petitioner has been posted to Nagpur, through-out since inception i.e. from the year 2009 and it is only now, for the first time, that the petitioner has been transferred from Nagpur to Kolkata."

"The post of the petitioner is transferable though, he submits, that there is no regulation fixing a minimum period of service at a particular station. But, he agrees that period of 13 years for a Government Officer to spend at one station continuously is very long period of time." "The object of transfer of Government Officers is to prevent creation of vested interests to promote transparency in the administration, and to ensure good governance. If a Government Officer remains posted for such a long period of 13 years in one go, the object and purpose of the transfer of a Government Servant gets frustrated. It, therefore, follows that a Government Servant like the petitioner, who has continuously remained fastened to Nagpur for 13 long years must not and cannot contend that he has a right to be at Nagpur and that he should not be transferred to a place like Kolkata. In fact employer of the petitioner has been quite benign so far, as could be seen from the fact of posting of petitioner at Nagpur even after his promotion."

"Keeping in mind, the object of the transfer of Government Officer and long continuous stay at Nagpur, we are of the view that now, the petitioner has lost his right to challenge his transfer from Nagpur to Kolkata."

"The transfer order, in our considered view, serves the object of transfer of the Government officers and has been issued in public interest as stated earlier, and, therefore, there is no ground whatsoever available here to find any fault in the transfer order."

Even after Sh. Kumar Kalbande's transfer, he used to visit Nagpur office. The then Regional Director, Regional Office (Central), Nagpur has prohibited his entry in the office premises by issuing a notice dated 17.08.2021, this notice was also challenged by Sh. Kumar Kalbande in the Hon'ble High Court on which Hon'ble Court opined as follows :

"By the notice dated 17.08.2021, entry of the petitioner in the office has been prohibited and the reason for the same is also stated. The reason is that, it was found by the superior officers of the petitioner that in spite of his transfer from Nagpur to Kolkata, the petitioner was visiting the office and creating some scenes, which have been described to be unruly... If this is so, we are of the view that the petitioner is indulging in a behavior unbecoming of a Government officer and this submission made on instructions on behalf of the petitioner is no less than misconduct on the part of the petitioner. On this ground as well, this petition deserves to be rejected."

Sh. Kumar Kalbande also moved to Central Administrative Tribunal, Mumbai Bench, Camp at Nagpur and filed O.A. 514/2021 against the same transfer order. After taking cognizance of the order of the Hon'ble High Court, the Central Administrative Tribunal disposed of the O.A. 514/2021 by stating that "Since the applicant's Writ Petition challenging the same transfer order as has been challenged in the present O.A., has already been rejected by the High Court order in the Writ Petition No. 3967/2021 dated 27.10.2021, nothing survives at this stage in this O.A. for adjudication by the Tribunal. Therefore, this O.A. stands disposed of. No costs. "

Further, during the hearing dated 18.12.2023 in the Court of Chief Commissioner for Persons with Disabilities (Divyangjan), Sh. Kumar Kalbande had again claimed that he had tried to join at his place of posting i.e. Forest Survey of India, Regional Office (Eastern), Kolkata. In this regard, it is to state that neither the Headquarter nor the Regional Office (Eastern), Kolkata (his controlling authority) has any information regarding his attempt to join at Kolkata in any form. Moreover, the Regional Director, Forest Survey of India, Regional Office (Eastern), Kolkata who is the controlling authority for Sh. Kumar Kalbande have informed to this office that Sh. Kumar Kalbande has never joined the Forest Survey of India, Regional Office (Eastern), Kolkata (letters enclosed as Annexure-III). It is pertinent to mention that during the hearing of the Court of Chief Commissioner for Persons with Disabilities (Divyangjan) dated 26.05.2022, Sh. Kumar Kalbande produced the video of Regional office, Nagpur in front of the court stating that the video is of Regional Office (Eastern), Kolkata and that he has tried to join, but he was refused entry. Hence, Sh. Kumar Kalbande tried to mislead the Court of Chief Commissioner for Persons with Disabilities (Divyangjan) by providing false information by way of showing video of Forest Survey of India, Regional Office (Central), Nagpur being shown as video of Regional Office (Eastern), Kolkata. Further, as per directions of the Court of Chief Commissioner for Persons with Disabilities (Divyangjan) dated 18.12.2023, a consolidated report of Sh. Kumar Kalbande has been sent to Court of Chief Commissioner for Persons with Disabilities (Divyangjan) (Annexure-IV).

In an email dated 20.12.2023, Sh. Kumar Kalbande mailed that the Office of DG, FSI Dehradun has denied him joining Kolkata office and in the email dated 23.12.2023 he has stated that he had already reported to Kolkata. But on the perusal of the videos annexed by Sh. Kumar Kalbande in his email dated 21.12.2023 it clearly shows that he had only asked the Security Guard about the lift whether it is working or not. Sh. Kumar Kalbande has neither entered in the building of Regional Office (Eastern), Kolkata regarding his joining. Hence, all the acts and statements of Sh. Kumar Kalbande are contradictory in nature. Further, CCTV cameras of the building of Regional Office (Eastern), Kolkata reveals that he just roamed around the building with his face totally covered with the clothes.

Hence, the claim of Sh. Kumar Kalbande that he has been refused to join Regional Office (Eastern), Kolkata is strongly denied. Moreover, Regional Director, Regional Office (Eastern), Kolkata have repeatedly informed him to join at Regional Office (Eastern), Kolkata (Annexure-III).

(ii) Regarding Subsistence allowance:-

Vide this office letter no. 13-15/2022-Admin-Part-1164 dated 17.11.2023, Sh. Kumar Kalbande was informed that as per the FR Rule 53, he is not entitled for subsistence allowance (Annexure-V). It is to inform that subsistence allowance is allowed only when the officer is under suspension, Since Sh. Kumar Kalbande is not under suspension his claim of subsistence allowance cannot be agreed to. Further, as per Fundamental Rule 17 (1), an officer who is absent from duty without any authority shall not be entitled to any pay and allowances during the period of such absence. As Sh. Kumar Kalbande is unauthorizedly absent, there is no provision to pay the salary for the period of unauthorized absence.

(iii) Regarding denial of Medical Treatment:-

Sh. Kumar Kalbande is unauthorizedly absent from the duty since 1/2021. He has been transferred to Regional Office (Eastern), FSI, Kolkata on 30.07.2021, and relieved from Regional Office (Central), FSI, Nagpur on the same day.

It is pertinent to mention that CGHS facilities can be availed by the Central government employees on fulfilling the extant criteria and on payment of the prescribed fees. In his case, fees for CGHS card, which is Rs 450/- per month could not be deducted by his office for almost 03 years (Regional Office (Central), FSI, Nagpur for the period from 1/2021 to 7/2021 and Regional Office (Eastern), FSI, Kolkata from 8/2021 to till date) as Sh. Kumar Kalbande is not drawing any salary for being unauthorizedly absent. The CGHS authorities have been informed about his unauthorized absence, non-payment towards CGHS card and his transfer from Regional Office (Central), FSI, Nagpur to Regional Office (Eastern), FSI, Kolkata. Moreover, in an email dated 28.12.2023 received from Sh. Kumar Kalbande, he himself attached the referral receipt of CGHS dated 26.12.2023 (Annexure-VI). This means that Sh. Kumar Kalbande is still using CGHS facility and on the other side, he is writing to various authorities that he has been denied medical treatment. However, with respect to denial of claim of his medical treatment, it is to state that this office has no role in denying him any medical treatment. Moreover, Sh. Kumar Kalbande was informed that in order to make any payment to Sh. Kumar Kalbande, Sh. Kumar Kalbande needs to be mapped on the PFMS at Regional Office (Eastern), FSI, Kolkata as he was relieved from the Regional Office (Central), FSI, Nagpur. Sh. Kumar Kalbande can be mapped only after joining his place of posting i.e. Regional Office (Eastern), Kolkata. Hence no tour advance, medical payment etc. can be given to Sh. Kumar Kalbande. Once he joins at his new place of posting all payment due to him will be cleared as per rules. Further, it was also informed to Sh. Kumar Kalbande that his all medical claim would be settled as per Government of India norms after his joining at Regional Office (Eastern). Kolkata (Annexure-VII).

It is also to inform that Sh. Kumar Kalbande uses different e-mail ids (kumarkalbande@gmail.com, kumaarkaalbande@gmail.com, kumaarkalbande@gmail.com and janardhan7680ma@gmail.com) for communication with different Government Authorities. Further, he writes his designation as JTA. Nagpur in some e-mails and JTA, Dehradun in other e-mails. But he is not posted at either of these places. This shows the dubious nature of Sh. Kumar Kalbande. It is clear from the above that he has not joined the Regional Office (Eastern), Kolkata.

As Sh. Kumar Kalbande was repeatedly visiting the Regional office, Nagpur (Former employer) and creating unruly scenes over there. Thus, the Inspector of Police (Crime), Gittikhadan Police Station, Nagpur City under the Section 149 of Code of Criminal Procedure 1973, have warned Sh. Kumar Kalbande that except the days of departmental enquiries he shall not venture into office or office premises of Regional Office, Nagpur or else strict action will be taken (Annexure-VIII). Further, all the complaints filed at Police Station, Gittikhadan by Sh. Kumar Kalbande have been disposed of (Annexure-IX).

Moreover, more than 50 RTIs, Appeals and Grievances on public grievance portal have been filed by Sh. Kumar Kalbande and all the RTIs, Appeals and Grievances have been suitably replied. Numerous baseless and false complaints have also been sent to Hon'ble President, Prime Minister Office, Ministers, VIPs, Court of Chief Commissioner for Persons with Disabilities (Divyangjan), UNHRC, National Commission for Backward Classes, National Human Rights Commission etc. by Sh. Kumar Kalbande.

From the above facts and information, it is clear that there is no violation of any Human Rights. All the actions initiated by the competent authority are purely administrative in nature and are also as per CCS (CCA), Rules 1965. Hence, the matter may be disposed of.
