#### Respected Mam,

This is with reference to unauthorised leaves sanctioned to Shri Chaturbhuja Bahera IFS 1996 by Director General of Forest Survey of India Dehradun.

The extension of Shri Bahera was expired on 30 April 2022. So Shri Bahera has applied for terminal leave to Director General, Forest Survey of India Dehradun as follows

- 1. 2/5/2022 to 31/5/2022 for 30 days (Annexure 3 Letter No 4-1/2021-Admin-3412 dated 14 June 2022)
- 2. 1/6/2022 to 14/6/2022 for 14 days (Annexure 3 Letter No 4-1/2021-Admin-3412 dated 14 June 2022)
- 3. 15/6/2022 to 30/06/2022 for 16 days.(Annexure 2 Letter No 4-1/2021-Admin-3411 dated 28 June 2022)

As per DOPT Letter F No 14017/06/2017-AIS-II dated 9/2/20218, The concern officers might be allowed leave not exceeding more than 2 months. The officer concerned should apply for further leave to state government.

Moreover, the terminal leave was granted only when the officer concerned are relieved from deputation.

Director General FSI Dehradun has granted terminal leave in three interval mentioned above in contravention of DOPT Guidelines.

After the first grant of terminal leave, Shri Behar IFS 1996 was already deemed relieve from Forest Survey of India.

I would like to bring your attention to letter no 4-1/2021-Admin-3857 dated 25 August 2022. Instead of PCCF HOFF J&K Forest Department, Director General has granted Commutted Leave to Shri Bahera for 15 days. Please refer Annexure 1.

As per DOPT Order F No 14017/06/2017-AIS-II dated 9/2/20218, Shri Bahera was already relieved from Forest Survey of India and Director General was not authorised/concerned authority to grant any leave to Shri Bahera.

I would like to bring your kind attention to instructions given in OMs that

- The Officers are deemed to be relieved after expiry of the Deputation
- In so far as Central Deputation as per clause 1.1 Under Rule 6(1) instructions issued vide this
  Department OM No 27(38)-EO 87 SM dated 20 May 1987 provide that on reversion of central
  Deputation, The officers concerned might be allowed leave not exceeding two months by
  concerned Ministry/ Department, And the officer concerned should apply for leave for State
  Government/Cadre Authority

The concerned official's terminal leave was over on 30 June 2022. After expiry of terminal leave, the official was deemed to relieved to J&K Cadre. Instead, from available records, the official has overstayed on deputation.

Director General FSI Dehradun has violated DOPT orders and granted Commuted Leave against DOPT guidelines.

The chances of corruption(money) can not be denied in this.

Further, MOEFCC has given the charge of Inspector General IRO Raipur to Shri Bahera on 27th July 2022 through Letter No 12026/05/2021-IFS-I dated 27th July 2022 (Annexure 11) even after acknowledgement of Letter of Cabinet Secretariat(Annexure 15) and Unauthorised leave sanctioned by Director General, Forest Survey of India Dehradun.

Please refer to Annexure 5 & 6, Representation for overstay and Unauthorised extension was sent to Secretary, DOPT, New Delhi and Hon'ble Minister of State, DOPT, New Delhi.

Through OM No 28/2/2023-EO(SM-II) dated 20/02/2023, DOPT has issued Office Memorandum to MOEFCC. Please refer to Annexure 14.

The said Office Memorandum is pending at Ministry though various representation has been made by the applicant. Please refer to Annexure 16.

Also to dilute various inquiries such as

Director General, FSI, Dehradun has given charge of Regional Director FSI Nagpur to Shri Bahera through Letter No 13-9/2021-Adm-3402 dated 13 December 2022. Please refer to Annexure 7. Ministry of Environment Forest and Climate Change further supported this order by issuing Letter No 12016/05/2021-IFS-I dated 6th December 2022. Please refer to Annexure 13.

I would like to bring your attention to **Voilation of Covid Guideliness**. In this regards, MOEFCC has issued the letter File No 7-12/2020-ROHQ(pt) dated 8 November 2021, Please refer Annexure 18.

The covid positive reports of Shri Bahera is attached in Annexure 21. Also through Letter No E-484-2019/423 dated 27/8/2021(Annexure 20), **Shri Bahera**, in his reply, mentioned that he never had covid 19 infection.

The statement of Shri Bahera contradicts his covid positive reports.

Further in Police reports, Shri Bahera mentioned that He was tested covid positive but he did not attend office and was in isolation. But there are many office staff reported that they met Shri Behara and along with them their family got Covid positive in that period after meeting Shri Bahera. However, DG,FSI, Dehradun did not conduct any inquiry on the letter File No 7-12/2020-ROHQ(pt) dated 8 November 2021issued by ROHQ Division of Ministry. Through his letter no Letter No 13-12/2021-Admin-3826 dated 18th August 2022, Shri Bahera has exonerated.

This is very surprising and utterly shocking that charged official is exonerated without even conducting single inquiry.

The chances of corruptions (monetary) can not be neglected in this case.

Hon'ble Secretary Mam, I am submitting these to you for required concern and necessary action earliest. An Action Taken Report(ATR) may be provided earliest.

Sir.

This Department has issued Consolidated Deputation Guidelines for All India Services w.r.t. Rule 6 of the IAS (Cadre) Rules, 1954 and analogous provisions in the IPS (Cadre) Rules and IFoS (Cadre) Rules, vide letter No. 14017/33/2005-AIS(II)(Pt.) dated 28<sup>th</sup> November 2007.

- 2. Clause 1.3 under para 3.2 of the said instructions issued vide letter dated 28<sup>th</sup>. November 2007 provides for inter-cadre deputation to another State Government, under Rule 6(2)(ii) of the IAS (Cadre) Rules, 1954 and analogous provisions in the IPS (Cadre) Rules and IFoS (Cadre) Rules. Maximum tenure of 5 years has been provided for this category, provided that the officer has completed 9 years in his own cadre and has not reached the Super-time scale.
- 3. In so far as Central Deputation as per clause 1.1 under Rule 6(1) is concerned, instructions issued vide this Department's OM No. 27(38)-EO (87 (SM) dated 20<sup>th</sup> May 1987 (copy enclosed) provide that on reversion from Central deputation, the officers concerned might be allowed leave not exceeding two months by the concerned Ministry / Department, and that the officer concerned should apply for further leave to the State Government / Cadre Authority. It is also to be stated that such leave is debitable from the leave account of the Officer.
- 4. The matter regarding extending these instructions to cases of inter-cadre deputation has been considered and it has now been decided with the approval of the Competent Authority that the said instructions dated 20<sup>th</sup> May 1987 as amended from time-to-time are also applicable to cases of inter-cadre deputations mentioned above.

Subject: Overstay while on deputation.

Undersigned is directed to refer to this Department's OM of even number dated the 17th June, 2010 and to say that as per existing intructions no extension in deputation beyond the fifth year is allowed. Further, as per the OM No. 14017/30/2006-Estt (RR) dated the 29th November, 2006, the deputationist officer is deemed to have been relieved on the date of expiry of the deputation period unless the competent authority has with requisite approvals, extended the period of deputation, in writing, prior to the date of its expiry. It is observed that despite these clear instructions, proposals for regularization of overstay of officers on deputation beyond the five year period continue to be received in the Department. It is reiterated that it will be the responsibility of the immediate superior officer to ensure that the deputationist does not overstay. In the event of the officer overstaying for any reason whatsoever, he/she is liable to disciplinary action and other adverse Civil/Service consequences which would include the period of unauthorised overstay not being counted for service for the purpose of pension and that any increment due during the period of unauthorized overstay being deferred with cumulative effect, till the date on which the officer rejoins his parent cadre.



#### Sir/Madam,

This is with reference to E-mail Representation to your office dated 12/05/2022 regarding reporting and intimation to overstay. (Please refer Annexure 14).

The Deputation of the Shri Bahera expired on 30/04/2022. (If you refer to Annexure 1 F No A-1911/1/2010-IFS-I dated 19 January 2021)

On expiry of Deputation, Shri Bahera has applied for terminal leave for one month with relieving from the deputation from FSI, CZ, Nagpur. (Please refer to Annexure 7 Letter No 4-1/2021-Admin-3412 dated 14/06/2022).

Shri Bahera has applied thrice for terminal leave from period 2/5/2022 to 31/5/2022 for 30 days and from 1/6/2022 to 14/6/2022 for 14 days. Further, he applied for terminal leave from 15/6/2022 to 30/6/2022. (Please refer to Annexure 6 Letter No 4-1/2021-Admin-3411 dated 28/06/2022.)Instead of reporting to his parent cadre department, he was managing his terminal leave from deputation office, which is violation of DoPT guideline. Extension should be given before expiry of deputation period, which was not in the case of Shri C. Bahera.

Please refer to Annexure 5 Letter No 4-1/2021-Admin-3857 dated 23 August 2022, after expiry of terminal leave Shri Bahera has been relieved from the FSI, CZ, Nagpur yet Shri Bahera has applied for Commuted Leave at DG, FSI, and Dehradun from period 1/7/2022 to 15/7/2022. Moreover, Shri Bahera has joined FSI, Nagpur on 21st July 2022 not on 18/07/2022.

Please refer to Annexure 9 F No A-19011-1-2010-IFS-I dated 13/07/2022. MOEFCC through DOPT Communication No 9/25/202-EO (SM.II) dated 12/07/2022 has granted extension after expiry of his terminal leave as well as relieving from the organisation from 13/07/2022 to 30/4/2024.



सितिश बीरेकर हया कर्मचाऱ्याने त्याच्या सहत्वा घरी आत्महत्त्वा केली असल्वाचे त्याच्या कुर्दुवियोंनी आम्हाला कळवले नाही. त्यामुळे त्याची आत्महत्या ऑफिसळडून होणाऱ्या त्रासामुळे झालेली आहे असे म्हणणे चूकीचे आहे. श्री काळबाडे मानी केलेल्या उक्तरीप्रमाणे आही कॉरोना १९ च्या कोणत्याही नियमांचे उल्लंघन केले गाही, त्यागुळे आनच्यागुळे कोणालाही कोरोना चा प्रसार झाला नाही. त्याबाबत कार्यालयातील इतर कर्मधारी देखील माहिती देव शक्तील आगन्या कार्यालयातील कोणताही कर्मचारी कोरोना आजारामुळ मृत झालेला नाही. तकारीत नमुद केलेली घटना व आरोप आमच्या कार्यालयात्री संबंधीत नाही.

माझे वरील मयाण माझ्या सोगण्याप्रमाणे संगणकावर टकलिखीत करण्यात वाले असून, ते भी वाचून पाहिले असुन, आमध्या ऑफिसमधील कन्सल्टंट - श्री संजय सिनेवार, पानी देखील थायून पाहन, ते मता हिंदीतून समजायून सायितले असता, बरांकर आहे, त्याखाली मी माझी सही केली आहे.

## REPLY TO GRIEVANCE REGISTRATION NUMBER: MOEAF/E/2021/01359 COMPLAINANT: SHRI KUMAR KALBANDE

The information sought in grievance has already submitted in the following communications earlier and the matter stands disposed off at various levels, including the FSI, HQ and MoEF & CC.

It is pertinent to mention that Shri Kumar Kalbande, JTA has been transferred to FSI, Kolkata on 30.07.2021 and stands relieved from FSI, Central Region, Nagpur. He is no more part of this office now.

Shri Kalbande was drafted for field work by Office Order No. 98 dated 13.01.2021, Office Order No. 154 dated 30.03.2021 and Office order No. 28 dated 19.07.2021 but instead of proceeding on tour he did not report to duty and remained absent without intimating the office despite reminders. He disobeyed the order without any justified reasons.

Before posting him for field work he was given work of FCM, Geomatic Lab, which is being done based on with help of remote sensing in Workstations, it was noticed that he was lagging behind the target given to him. Hence his colleges in Geomatic Lab were asked to check the work done by him from his Computer. It was found that he has done very less work. In order to complete the remaining work and submit to headquarter office in time, this work was completed by other staff in the Geomatic Lab.

He is in the habit of remaining absent or attending office late and leaving the office early without informing any officers in the office. It is evident from the Bio-Metric attendance. It is pertinent to state that the Audit Party from Environment & Scientific Departments, Mumbai has also pointed out this fact and has calculated an amount of Rs.7,08154.00 as excess payment made to him to be recovered from him.

The Lady staff members of the Geomatic Lab has complained that he used to watch explicit and obscene contains during office hours and they found some obscene photos kept in his computer. The matter was investigated by the Internal Complaints Committee under Sexual Harassment of Women at Work Place Redressal & Prohibition Act, 2013 and the findings has been submitted to the competent authority.

The complainant despite office order and repeated instructions not to attend office and proceed to field for NFI work has not done so. He has been transferred to FSI Eastern Region

and was relieved on 30,7,2021 even then he was frequently visiting this office and abused the office security Guard and created unruly seen, broke window panes and Glass doors in the office. In this background a para-wise reply is as below:

The Regional Director, Forest Survey of India, CR, Nagpur is strictly following the Covid19 guidelines and norms issued by State Government and as well as the local Bodies. If any staff members is not attending the given work and disobeying the orders of the Superior Authority, it is treated as per the F.R. the provision of FR 17 (1)b. The Cardinal principle is "no work no pay". This is being followed by this office and hence it can not be termed as humiliation, victimization and harassment. The action taken by this office is as per prevailing Rules and not arbitrary. Thus no violation of Fundamental Rights of any staff members. All Govt servants are bound by Rules and Regulations framed by Govt. of India.

The complaints in all the paras have been submitted by the complainant time and again to harass this office as vengeance due to actions being taken against him for his misconduct, negligence and indisciplined behaviour besides habitual absentism. All the paras have been replied vide Letter to RO, IRO, MoEF& CC, Nagpur No. 6-9/95/C/Vol.II/26 dated 11.8.2021 to RO, IRO, Nagpur who was directed by the ministry to enquire into in pursuant to the complaints by Sh. Kalbande. Sh Kalbande writes numerous letters, without attending duty, to various authorities day in and out to create some nuisance and some sensation by false irrelevant matters.

- The Regional Director never had any symptoms of Covid 19 at any point of time, not even fever for last 9 years.
- 2. This is an imaginary situation which has not occurred in the office. This is evident from the fact that the office had only 02 cases of COVID. Shri Kalbande has come to office only for 01 day, i.e.,on 12/3/2021 during last 08 months. He had COVID in 2<sup>nd</sup> week of December 2020 before the joining of the Regional Director on 30.12.2020. The Regional Director never had Covid 19, there is no question of spreading it and putting life of employees and their family members in danger.
- 3. Sh Kalbande has never gone to field for NFI works any point of time since his joining on 11.5.2009 in the organization. There was no COVID during all these years. He wants to hide his incompetence, absentism under COVID plea as he remains unauthorizedly absent habitually more than 200 days every year. It is informed that the field parties were sent to complete the target of NFI Work within the time frame as per the head quarter instructions received from time to time. The basic work of this office is to do the survey of Forest in various States. The field staff have to follow the Covid 19 guidelines and norms prevailing in the State they are visiting. They have to follow the same measures as the Forest Department of the concerned state. It is well-understood that office or field work alone is not reason for few staff getting infected by Covid 19, there may be some other reasons. It is clear from the fact the complainant had COVID though he never attends office and sits at home. He never goes to field even in normal time. The argument is self-defeating.
- 4. The complainant Sh. Kalbande remained unauthorizedly absent from duty. He has filed a case in Nagpur CAT, which came up for hearing today, i.e. 27.08.2021. Some other staff has filed OA 2065/2021 and 2066/2021 in CAT Nagpur besides two writ petition 6452/2021 and 6453/2021 on grounds of service rules and avoided field work in spite of the fact that court held that the demands of the STAs are unjust. As per the provisions of FR 17(1)b the principle of no

work no pay was applied to. The matter is sub-judice now, All Government servants are bound by Rules and regulations framed by Govt. of India failing to observe the Rules will attract penal provisions of CCS Conduct Rules.

- Hardly 15% staff work in the office and they attend office strictly following Covid 19 norms. There is huge space in the office, no crowding. Those 7-8 staff coming to office have their own rooms. These are also the staff related to accounts and establishment, which are essential works to run the basic minimum of an office.
- Death of Sr. Draftsman by committing so called suicide (officially it is reported by the Family that death was natural), It has no relevance with the office work but it was purely his personal matter. The complainant wants to sensationalize the issue to draw favour and spread bad name of the officer.
- Such incidence has not happened in this office. This is out of context.
- 8. The field officials were sent on field work to fulfill the target as per the timelines set of the HQ in view of the ISFR-2021 following Covid 19 guidelines and norms in the respective State. The field work can not be a reason for the Covid 19 infection to the family members. The official, if any had covid, had to be treated under the governing rules and paid as per norms. The complainant can't canvass various stories with malice behaving like custodian or spokesperson for unknown persons.

This office is following prescribed Rules for the working in office and in field scrupulously. There is no violations of any Rules and Regulations, Human Right/Fundamental Right issued by the Govt. The complainant himself is not following the justified order of his Superior Officers. He has approached all quarters including various Union Ministers, Ex-Chief Minister of Maharashtra, Union Leaders, Commissioner, Police etc. He has approached the DG, FSI; DG, Forests and many officers of the ministry personally and through various representations. Since his activities are unlawful, he is not getting any relief from any source.

Thus from the above submission it is clear that the complainant is totally frustrated because he is being asked to do the required field work as a JTA and hence making frivolous complaint. However, he is no more part of this office as he stands relieved in pursuant to his transfer to FSI, ER, Kolkata.
