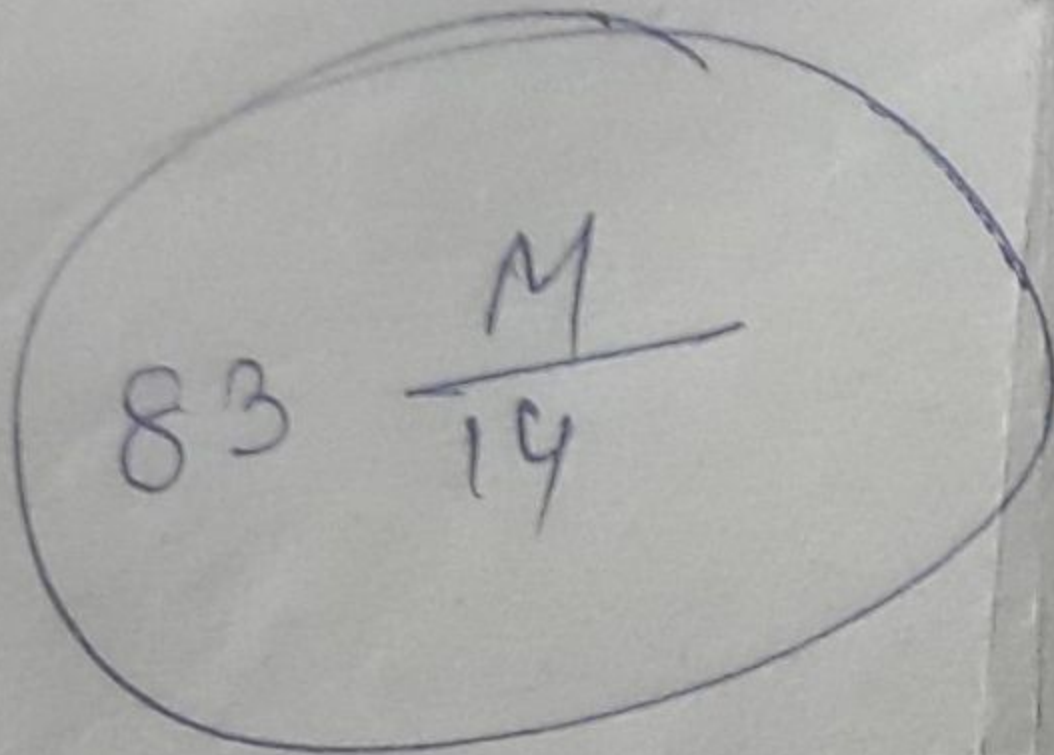

# PROCEDURE FOR PROCUREMENT OF MAPS / DATA FROM FOREST SURVEY OF INDIA

## 1. FOREST COVER MAPS

### HARD COPY (UP TO A0 SIZE) / SOFT COPY OF MAPS

FSI supplies the hard copies of Forest Cover/Type maps on 1:2,50,000/ 1,50,000 scale. Survey of India's Topographic Maps Numbering system is adopted by FSI. We may supply the district wise map also.

## 2. Digital Geo-referenced Data

Forest Survey of India provides Digital geo-referenced Data of Forest Cover/Forest Type in img & geotiff formats. The user may overlay any spatial layer over the same as per his requirement.

The supply of the soft copy of the Forest Cover/Type maps will subject to the under mentioned restrictions:-

- i) The CD containing the Digital Data/Map of the Forest Cover / Type should not be copied.
- ii) The data should not be used for commercial purpose by the user.
- iii) The data should not be transferred to any other organization or individual nor be put on internet or given to media.

All requisition of Maps/Data should be addressed to the **Joint Director, FGD, Forest Survey of India, Kaulagarh Road, PO – IPE, Dehradun – 248195, e-mail id: jdnfdmc@fsi.nic.in**. The cost and postal charges of maps should be remitted through **Non-Tax Receipt Portal (NTRP) of Government of India ([www.bharatkosh.gov.in](http://www.bharatkosh.gov.in))** to Forest Survey of India (FSI), Dehradun in advance along with map Indent and receipt should be sent through e-mail. Payment through Demand Draft or Cheque will not be accepted. User guide for payment through NTRP Portal may be downloaded through FSI Website or through NTRP Portal. Indentors should provide their full postal address with PIN CODE and Phone Number through e-mail for Data/ Map Supply.
