Sir,

With due respect, it is to inform you that I have been serving as a Junior Technical Assistant in Forest Survey of India, Southern Zone, Bangalore for the past three years. Since my joining in this organization, I have always shown dedication towards my work by performing duties in the remotest areas of the forest, in almost all the southern states, that too in odd and adverse conditions and has contributed a lot to this organization.

But, since last year I have been facing some health issues. Last year, in February, while I was working in the State of Karnataka, I had suffered from skin allergy issues due to non-suitability of food and climatic conditions prevailing over there.

Earlier in this year also while I was working in the State of Kerala, I had suffered from the same health issues, skin rashes and itchiness after consuming the food. The Doctor in Karnataka with whom I had consulted for this health issues had suggested me to change the place, because, in his opinion, climate may be one of the reasons for this health issues and to my surprise it worked. After visiting Delhi, skin rashes and itchiness went off automatically. This time I was on medical leave for five days. After that I had joined the crew doing the fieldwork in the State of Kerala and after finishing the work there I proceeded to Tamil Nadu state and currently am doing the field work there. Here also I am suffering from the same health issues, but this time the problem doesn't get cured in a quick time. Whenever I am affected by this issue, I am visiting local hospitals for treatment and every time the Doctors there suggests to consult a Dermatologist. Many times when I am working in remote areas finding a hospital or a doctor for this problem becomes a difficult one and also finding a Dermatologist near the working area is a very difficult one. As per the local Doctor's prescription, I am taking some sedative medicines in every night that makes me dizzy next morning and I am not able to concentrate on my work during the day, but somehow I am trying to accomplish my work without compromising on its quality.

Since, my skin allergy persists even after getting treatment continuously and I don't have anyone to look after me here, every time I have to travel from Bangalore to Delhi, where my parents are residing, to get myself treated over there. Travelling such a long distance in emergency condition for such a short period of time and that too on regular basis makes me do

out of pocket expenditure. Also because of the tiredness caused by continuous travelling, I am not able to concentrate on my work.



Also many of my family members, reside there, will be available for my help whenever I will be in need and also I don't have to travel long distances to treat myself.
