Respected Sir,

This is with reference to police Statement for Stolen HDD. The accused official were summoned to the Bajaj Nagar Police Station, Nagpur and had given statements.

The statements were requested in terms of stolen HDD but the accused along with her friends has given a statement that inquiry for stolen HDD is in process with office.

I have submitted an RTI to Police office and will submit their statement for your perusal immediately after i received the copy.

I have also read disturbing statement of Aprajita Yadav, S Technical Assistant. In her statement, She had mention that she has been chased and i called her on phone. For evidences, she shared recording when i came to office for departmental Inquiry.

I request you to check call records from Police for entire 2 years. If they find any calls from my number, i am ready for punishment.

Regarding chasing her, these two women's started taking video in office whenever I going to CAT case, Labour Commissioner Office, PESO in CGO Complex. On 24th January,2023 during the Inquiry these two were again capturing video where these two work on 6th floor and Inquiry was on ground floor of the office.

It would not be out of context to brief the background of these two women officials. Please refer to Annexure 2.1 to 2.15. The list of WhatsApp chats where both of them used unparliamentary language to Seniors such as DGF. DG. RD DD AD and STA colleagues. On many instances they are admitting manipulation of Area of ISFR.

In Annexure 3, Please find email representation to chairman of ICC for stalking me on social media.

I would like to submit about Most disturbing thing done by Smt Ganorkar that she has filed RTI for knowing the status of my confidential chargesheet regarding certificate.

This is the level of extreme vengeance these women's have.

It's unfortunate and shocking that, CPIO Shri Naik AD FSI Nagpur has provided my personal information which should be not be disclosed under 8(i) of RTI Act.

Because of them Shri Shankar Dharmik Peon (Daily Wager) was fired from Forest Survey of India Nagpur before one year of his retirement.

After promotion of JTA to STA, many conflicts starts in the office of RD,FSI, CZ, Nagpur. Many office staff are in fear. After joining of DG Sir, everyone is still waiting for his visit to Nagpur office since 1.8 years in order resolve their Grievances.

Please refer to Annexure 5, Chapter 5 Of 12(a) Aggrieved women should be given transfer.

In Annexure 1, Miss Aprajita Yadav has already requested transfer to Dehradun/Jaipur. As per her statement in Police station, She submitted her illusional statement that she is getting chased by 50% Landmark Locomotor Disabled Person.

But Officials of FSI is keeping her transfer request pending and igoring transfer of Aggrieved women at such extreme situation. From actions of FSI Officials, it is evident that they wish any mishap/unfortunate incident to happen.

Sir, I am disabled and belongs to Nagpur. Even if i get transferred anywhere in the world, there are so many family members and relatives lives in Nagpur. Miss Aprajita Yadav forcefully tried to involve my relatives and family members in this complaints.

I can never change my native place and that is why it's called native. Neither my relatives and family members can leave Nagpur for safety of outsider.

But for her safety and as per Women's Workplace Harassment Act 2013, Provision to transfer Aggrieved women is available. And living with her parents, she would be much more safe.

Same is situation with Smt Rohini Ganarkar. Her husband is from Andra Pradesh. Bangalore/Vijaywada/Hyderabad is closest to her. That's why she had submitted her options to Hyderabad Andra Pradesh in Annexure 1 of posting.

Because of work pressure at home and other issues, she is late to office for 179 days out of total 189 days of calculated attendance.

As per DOPT orders, Women should be posted to place where her husband works or reside. As per Women's Workplace Harassment Act 2013, Provision to transfer Aggrieved women is available.

It is pertinent to mention that Nagpur is not hometown for both them. They specifically requested their transfer to near to their home.

However, FSI administrative officials has kept their request pending.

Specially after her statement in Police station, if they are feeling unsafe it would be best for boths safety to grant them transfer to their native place or nearest to place where husband reside.

Because of them, I have requested transfer to any MOEFCC office in Nagpur other than FSI, but even that is kept pending.

Some officials of FSI may have personal interest by unnecessarily increasing conflict and use that conflict and complaints against me for defamation.

This is my humble request to kindly do the necessary. I will submit their statement, once i receive them through RTI.

I shall be obliged if you do the needful immediately.




