If you refer to Annexure 2.1, it is newspaper article of employee committing suicide. Besides these director was involved in case of installing CCTV Cameras in Ladies bathroom. FIR Copy and Newspaper cutting is attached in Annexure 8.

Annexure 6, SC Commision has found the officers of FSI guilty and would be imposing penalty of atrocity in couple of days. Also 2 hearings of Disability court has also taken place.

Please refer to Annexure 9.1, This office has made me trespasser in order to perform their illegal activities. Further if you refer to Annexure 9, they have filed missing report of my personal file of entire staff.

In order to ruin my life, they have decided to ruin the life of Divyang person (Annexure 7), and forced sexual harassment charges however even after 3 years could not able to prove it. By stealing my HDD they have copied data in office computer stating that it belongs to me and did harassment to women.

In front of Chief Commissioner for Person with disabilities New Delhi hearing, it is stated that central forensic lab Pune has confirmed traces of documents found in hdd in case sexual harassment of women with workplace.
