This is to inform you that on 07/09/2020 a printout of Sh. Kumar Kalbende, JTA addressed to his family friends was found on his table wherein he has stated that 'Muzo suicide karane se pahale hi sap logo se bat kar leni thae'. It had caused lot of tension amongst his official colleagues as he was absent in the office also. Accordingly we were preparing to report the matter to the Police meanwhile his brother has traced him and informed that Sh. Kumar Kalbende was very much in his quarter. Then we went to Local Police Station, Gutikhadan Nagpur and narrated the entire episode to the on duty Police Official. After going through the contents of that printout, he scolded and reprimanded Sh. Kumar Kalbende and advised us to take undertaking from him and take official action against him, if deemed fit. Accordingly, Sh. Kumar Kalbende, JTA, submitted an undertaking stating that he has been undergoing treatment for mental stress for the past some time. He was referred by OHS Doctor to a Psychiatrist Dr. Sankar Prasad in the month of June, 2020 (Prescriptions attached). He has also submitted unconditional apology for his mistake.

It is therefore requested that Sh. Kumar Kalbende, JTA may kindly be medically examined and give a report of his suitability for presently assigned duty. Office may further be advised in the matter.




