Respected Sir

With reference to above mentioned subject, I would like to inform you that the field parties for Orissa work returned to office amid pandemic and there is no order on my name for field yet Regional Director is refusing to let me join the office on verbal instruction and Mr A H Ansari Jr Hindi Translator on his verbal instruction kept attendance register to himself and does not let us sign the attendance register. When I requested give me in the writing why I can't join the office all they say it's oral orders of Regional Director. I don't think RF have such order it's Mr A H Ansari taking out his personal vengeance. Because there is no proof to it that Regional Director instrcuted it as there is no order.

When I went to office 2 weeks ago tried to sign the attendance Mr A H Ansari Jr Hindi Translator has erased my entire month attendance by drawing straight line on it. Because he keep attendance register to himself. I am attaching photo of it.

Today on 10th May 2021 when I went to office Mr Parikshit Agarkar signed register late at 11.20 pm while me along with 7 other field staff denied to sign the attendance register even though we were at time. i have video recording of it . Mr Parikshit Agarkar was on covid leave for more than 42 days yet he got his salary while when I was on Covid leaves they forcefully denied my salary by ordering me to field without even letting me join the office.

Also When I went to information officer to ask for first appeal authority to write first appeal on refusal of information, it was denied by Assistant Director who is first information officer. I also have that in video recording. Office is refusing to take RTI and refusing to give me receiving stamp on letter I want to give so that i can't even approach to court.

This is harassment at its peak during pandemic. It's 5th month without salary drawn to me. I have reached my limit of tolerating this harassment. Kindly take appropriate action on Mr A H Ansari Hindi Translator Assitant Director and Dispatch Section and allow me to do the Office work under appropriate rules.


This has reference to your work letter no. 13-4/2022-admin (part)-3951 dated 14/02/2024 on the above cited subject.
