Respected Sir,

This is with reference to letter no Letter No E-426-2009(Vol.III)/389 dated 27/7/2023 to Additional Director CGHS Nagpur by Shri Chaturbhuj Bahera.

In this regards, it is requested to kindly provide the Note Sheet for approval by appointing/Disciplinary authority within 2 days. In absence of your approval, the letter shall be treated as letter written in private capacity and I am also requesting you to initiate legal process on it.

You are requested to kindly refer to letter No 6-9/95/C/V/12 dated 17/02/2021, Shri Bahera has issued letter 3 years back, which has violated office secrecy act and ICC Act(Chapter 5 Point 16 Prohibition of publication or making known contents of complaint and inquiry proceedings.) which accounted for extreme defamtion. However, ICC has not even issued me any Inquiry letter when Shri Bahera issued letter to CGHS.

Surprisingly, this was not enough, Shri Bahera has issued repeated letter and the latest letter has created extreme defamation to Divyang person.

In Letter No E-426-2009(Vol.III)/389 dated 27/7/2023, Shri Bahera has mentioned that

1. I am Ex JTA of FSI CZ Nagpur but despite of sending it to current employer, he had issued letter in private capacity
2. He submitted false information that I am unauthorisedly absent since 4th December 2020. However, i have letters of IO that I am regularly present in inquiries since September 2021.
3. Shri Bahera mentioned that in order to delude and thwarft the grave charges levelled against me with support of frivolous grounds of health problems on the basis of medical certificate issued by CGHS. The official is doing correspondence who is not authorised for any communication.
4. The office has denied me attendance through RTI and despite being present in inquiries, you are continued to stop my double transport allowances, CGHS, HRA and other allowances Since September 2021.
5. CGHS Officials has issued a file to close my card and it's matter of time, it will be closed due to fabricated unauthorised communication by your office.
6. Despite Shri Bahera found guilty in covid case, he is regularly doubting integrity of CGHS Medical Officers. It is to threatened the officers so that I should not get proper healthcare.

Since 3 years, Shri Bahera has been obstructing my treatment which resulted into extreme atrocities accounted for poor health and disabilities to Divyang OBC Central Government Employee which could have been avoided. Despite of following your orders repeatedly, you are denying my salary but surprisingly forcing ex parte inquiries in absence of allowances by officials who has been alleged of bias repeatedly.

You are requested to kindly provide me details of your approval with Notesheet approved by you immediately. In case, if it is not approved by you, please direct appropriate action in this regards and allow me to take legal actions

for this.

This is humbly requested that I am in unbearable pain as you continue to deny my medical emergency operation.

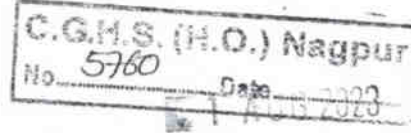

Subject: Issue of medical certificates to Shri Kumar Kalbande (beneficiary id-2542439) from different CGHS Dispensaries-reg.

Sir/Madam,

It is to bring to your notice Shri Kumar Kalbande, ex-Junior Technical Assistant of this office whose beneficiary id is 2542439 was transferred from this office to the Forest Survey of India, Eastern Zone, Kolkata and relieved from this office on 30.07.2021. However, he has not joined his duty at the new place of posting even after a period of 23 months have been elapsed.

Before his transfer from this office, Shri Kumar Kalbande was unauthorizedly absent from duty since 04.12.2020. Due to his unauthorized absence, this office has not drawn his salary since January 2021 till July 2021. Therefore, his CGHS recovery has not been made by this office since January 2021 to July 2021 and thereafter also, he is unauthorizedly absent from duty till date.

Following three disciplinary proceedings against Shri Kumar Kalbande, ex-Junior Technical Assistant of this office are already in the enquiry stage in the case of;

- i) Sexual Harassment of Women at Workplace,
- ii) Producing fake experience certificate for securing job and
- iii) Unauthorized absence from duty since 04.12.2020.

The departmental enquiry against Shri Kumar Kalbande for above charges is held in this office as and when decided by the Inquiry Officer. However, it is seen that in order to avoid the enquiry proceedings, he is in the habit of approaching various CGHS dispensaries in Nagpur before the date of enquiry, on one or the other pretext and forward the medical certificates obtained from the doctors to this office. Few instances are given below:

the grave charges levelled against him with support of frivolous grounds of health problems on the basis of medical certificate issued by CGHS.

In this connection, it is further stated that in earlier various occasion, the matter regarding issue of questionable medical certificates to Shri Kumar Kalbande by doctors of various CGHS dispensaries were brought to your notice ( copies of correspondences enclosed).

Shri Kumar Kalbande is apparently fit and fine. This is evident from the fact that even after obtaining unfit medical certificate from the CGHS doctors, Sh.Kalbande is regularly attending the inquiry proceeding as and when scheduled in this office. He is always trying to delude and thwart the grave charges leveled against him with the support of frivolous grounds of health problems on the basis of medical certificates issued by the CGHS doctors.

The recovery of CGHS contribution in respect of Shri Kumar Kalbande is not being made since January 2021, whereas, he is regularly availing the CGHS facilities.

It is therefore, requested to kindly examine this issue and do the needful.





उपरोक्त विषय पर श्री कुमार कालबांडे की ई-मेल दिनांक 15.01.2024 के संबंध में यह सूचित किया जाता है कि श्री कुमार कालबांडे दिनांक 04.12.2020 (जांच के दिनों को छोड़कर) से अनाधिकृत रूप से अनुपस्थित है एवं दिनांक 30.07.2021 को क्षेत्रीय कार्यालय (केन्द्रीय), नागपुर से क्षेत्रीय कार्यालय (पूर्वी), कोलकाता में स्थानांतरण के पश्चात अभी तक उनके द्वारा क्षेत्रीय कार्यालय (पूर्वी), कोलकाता में कार्यभार ग्रहण नहीं किया गया है। केन्द्रीय सरकार स्वास्थ्य योजना का लाभ लेने के लिये वेतन से योगदान हेतु सरकारी नियमानुसार कटौती की जाती है। चूंकी श्री कुमार कालबांडे को अनाधिकृत रूप से अनुपस्थित होने के कारण वेतन देय नहीं है एवं केन्द्रीय सरकार स्वास्थ्य योजना का लाभ लेने के लिये श्री कुमार कालबांडे के हक में योगदान जमा नहीं हो रहा है एवं श्री कुमार कालबांडे द्वारा बिना योगदान करें केन्द्रीय सरकार स्वास्थ्य योजना का लाभ लिया जा रहा है जो कि disciplinary proceedings के दौरान CGHS accredited hospitals के medical certificates से सर्वविदित है। इस कारणवश पारदर्शिता का परिचय देते हुए क्षेत्रीय निदेशक, भारतीय वन सर्वेक्षण, क्षेत्रीय कार्यालय (केन्द्रीय), नागपुर द्वारा CGHS को लिखा जाना स्वाभाविक है। इसलिये क्षेत्रीय निदेशक, क्षेत्रीय कार्यालय (केन्द्रीय), नागपुर की गयी समस्त कार्यवाही उचित है।
