This with reference to OM No28/2/2023-EO(SM-II) dated 20/02/2023 of DOP&T issued by DOP&T to Shri Neelesh Shah. Joint Secretary, MOEFCC, IP Bhawan New Delhi. Please refer Annexure 5.

After multiple representation to Shri Neelesh Kumar Shah. JS, MOEFCC through email and phone, action taken report was not provided to me.

Further, I raised the Grievance for Inaction at CPGRAM through MOEAF/E/2023/0002773 dated 9/9/2023. For the same, Under Secretary, FE, MOEFCC has issued Letter No 17-10/2020-FE(E-136946) dated 5/9/2023 to DG,FSI, Dehradun who has sanctioned leaves for the official who has been already relieved from the department beyond the terminal leave period. I raised appeal to Appellant Authority for the same concern, again DIG Forest Issued letter No 17-10/2020-FE(E-136946) dated 5/9/2023 to DG,FSI, Dehradun.(Annexure 3)

To my utter shock, I received the reply from charged official through Letter No E-484/2019/. Dated 13/10/2023 stated words such as **Whims and Whimsical Ambition**. (Annexure 1)

The charged officer has humiliated me on papers through CPGRAM in order to Intimidate and issued letter without any dispatch number to it. Moreover, the charged officer has got explanation call for unauthorised Forest Clearance ie Illegal Mining at Chhattisgarh area.

I am reporting you inaction on office memorandum OM No28/2/2023-EO(SM-II) dated 20/02/2023 of DOP&T by Authorities of Ministry of Environment Forest and Climate Change.  
Further, requesting you action at your end for inaction and disobedience to your office memorandum by authorities of Ministry of Environment Forest and Climate Change, New Delhi.
