Respected Sir,

The RD FSI CZ Nagpur stated that "Shri Kalbande has received the copy of transfer order and relieving order from RTI information given by FSI EZ Kolkata on 23/2/2023" which confirms that RD FSI CZ Nagpur did not given me any transfer order or relieving order till date in my hands. The transfer happened on 30 July 2021, Through RTI, the copies received after 19 months. Till date, RD FSI CZ Nagpur has not given me reliving order and transfer order due to unauthorised trespassing order issued by RD FSI CZ Nagpur.

You have issued Letter No 7-4/2010- Admin-460 dated 26/02/2021 and till date RD FSI CZ did not take any action on that letter. Further, more than 170 earned leaves were present before you issued the order on 20th February 2021. On 1st July 2021, I have additional, 15 Earned Leave and 10 HPL credited to my account. Even after that RD FSI Nagpur did not pay me any salary.

To further surprise, Covid Period and Covid Medical Leave can not be made dies non as per OM No OM No 13020/1/2019-Estt(L) dated 7th June 2021. I repeatedly went to office to submit my representation for regularisation of leave but my entry was denied by office. Since you have opened channel to submit my representation directly to you, this is again humble request to kindly regularise my leave as per said OM of Covid period.

In Annexure 1 RD FSI Mentioned that "There is no such charge or anything, in case anything is pending it will be communicated to current employer". The statement itself is contradictory. I have letter to handover the

charges, RD FSI has not allowed to me handover these charges. Suitable action is requested at your end. Please refer to Annexure 14 OF No 35 dated 30/7/2021 which is not signed. In this, RD FSI CZ Nagpur has asked me to apply for NOC. **His current statements are contradicting with his previous orders.**

In annexure 16Letter No E-484/2019/194 dated 25/5/2023, It is stated that " Paucity of funds" from DG FSI Dehradun office is responsible for non payment of medical bills. Further, it is also stated that i did not submit NPS form. Please refer to Annexure 17, The NPS form is already submitted as desired. Further, if there was paucity of funds, withholding NPS 25% advance during medical emergency can not necessary. **There was no paucity of funds at my NPS saving during Covid times.**

Further, paucity of funds for such long time is not my fault but administrative failure.

First RDFSI Nagpur has withheld my salary without your permission by erasing Attendance register when i was present in office.

Later, He stopped my medical bills under Paucity of Funds.

Stopping my NPS Money for my covid treatments by RD FSI Nagpur has no reasons at all.

Paucity of funds of your office is not my responsibility and neither is denying of 25% NPS money. Further, there was Non payment of 15 Earned Leave and 10 HPL credited on 1st July 2021. **So, I was with zero payments and RD FSI Nagpur was additionally withholding more than 3.5 lakhs rupees**. Since there is no office order for stopping salary from Disciplinary Authority, I have doubt that RD FSI Nagpur has taken my salary and used it for stock market and illegal online stock market tradings. Rd FSai CZ Nagpur has additionally getting inquires for Forest Clearance of Mine in Chhattisgarh and vigilance complaints are pending against him.

Through Letter No Letter No E-484/2019/..... dated 13/10/2023, it is stated that TTA will be given to the place of posting. But, if a person is Unauthorisedly absent then official can not be relieved from office. Further, while nominating for filed work of Orrisa & Ujjain, RD FSI Nagpur has relieved me and hence applied "No work No Pay".

When RD FSI CZ Nagpur claimed to be relived me for public interest transfer, i was not paid salary for 7 months ie zero money was present to me on the reliving day because of paucity of funds from the department. In order to obey your order, RD FSI Nagpur has purposely did not left me any money.

Please refer to Annexure 3 Letter No E-484/2019/..... dated 13/10/2023. Ad per this letter, RD FSI Nagpur stated that LPC was issued to me through CPGrams dated 25/5/2023. If LPC is issued on this date, why is that chargesheet for not joining has issued to me without first issuing LPC.

It is very surprising that LPC issued date is 22/11/2021 where it is mentioned that LPC is handover to transferred official and he was allowed to join the place of posting within 12 days. Most importantly, i was already tresspasser in office by 17 August 2021.

On other hand RD FSI CZ Nagpur claim that i was relived on 30 July 2021. Whereas, He submitted that RTI is place where transferred official gets his reliving orders. Shockingly, the RTI was received on 23/2/2023.

Under any circumstances, either LPC can be authorised or Trespassing Order Or Reliving order received through RTI can be authorised.

Unfortunately, Office of RD FSI CZ Nagpur has not given authorised LPC NOC TTA and Reliving order in my hands.

Please refer Annexure 1, 3 & 16, Either Dispatch Number is missing or signature is missing. You may please take a note of evantures of RD FSI CZ Nagpur.

Please refer to Annexure 1 Letter No E-484/2019/..... dated 13/10/2023, it is mentioned that matter related transfer to Kumar Kalbande has dealt by High Court and CAT with strictures of unbecoming Government Servant.

I am welcoming you to listen the audio of court case Hon'ble Chief Commissioner for Person with disabilities for obstructing transfer of Divyang Person(ie me)

Hon'ble Chief Commissioner was about to remove the Deputy Director during the hearing for not providing documents. Moreover, there are no such strictures in court case.

Most importantly, RD FSI CZ may have forged/fabricated court order copy as it is not certified copy and government certainly can not rely on uncertified copies of court.

My grievances are for authorised reliving not for transfer. I have no interest in filing grievances repeatedly which were resolved authentically.

So, i am humbly requesting you to address following issues immediately

- 1. Authorised LPC
- 2. Regularisation of my medical leave as per OM No 13020/1/2019-Estt(L) dated 7th June 2021.
- 3. Repatriate from nominated field work to FSI CZ Nagpur and allow me to relieve for Kolkata immediately by joining my current office.
- 4. Action for not allowing me to Handover Store, Library & Forest Cover Mapping charge (Whereas Data is already used for previous ISFR)
- 5. Credit my balanced leave Salary
- 6. Non payments of subsequent allowances without your permission
- 7. NPS Advance withdrawal and medical bills money withheld from 3 years under false paucity of funds from your office
- 8. Locking office Doors on 2 & 3rd November 2023.
- 9. False submission of Regional Director FSI CZ Nagpur that I am unauthorisedly absent from more than 2 years whereas I am attending inquires regularly.
- 10. Unauthorised trespassing order
- 11. Disobedience of your order no Letter No 7-4/2010- Admin-460 dated 26/02/2021
- 12. Unsigned & Issuing letters without dispatch numbers
- 13. Refusal of no dues certificate from office.
- 14. Please direct RD FSI Nagpur for support as per section 38 of RPWD Act 2016 for joining Kolkata Office
- 15. FSI EZ Kolkata has non functional lift.
- 16. Subsequent allowances in order appear for the inquiries in favour of natural justice and in order follow your orders for verification of health.
- 17. All the inquires has crossed time limit of 6 months (Crossed 20 months already since appointment of IO)
- 18. Seeking appointment to meet you from 20th November to 24th November 2023(I can not attend calls since you have stopped my treatment of ENT)

The matter regarding transfer of Sh.Kalbande has already been dealt by CAT & High Court and the court has dismissed his plea with strictures that his acts are unbecoming of Government servant. He had raised the issue that he had received the unsigned copy of relieving order. The matter has been disposed of by the Hon'ble High Court and CAT.

He has received the transfer order/relieving order in many occasions by mail during his transfer and subsequently through letters, RTI requests/Appeals etc. He has been chargesheeted for not joining at Kolkata and remaining unauthorizedly absent.

Matters decided by court are not dealt under PG portal. Grievances of service matters are also not dealt in the portal. He should make representation if any through RD, EZ.

With regard to the above cited grievances of Shri Kumar Kalbande, it is stated that Shri Kumar Kalbande, ex-JTA of this office is raising the issue of his relieving order, issue of NOC, issue of Last Pay Certificate, Handing over charge of library and store and Transfer travelling advance, issue of his 25% NPS advance and pending medical bill etc. repeatedly which is baseless and a meaningless exercise from his side. This is an attempt by him to fabricate concocted story to not to go to Kolkata as he has never attempted to go to Kolkata at any point of time.

As regards his aforesaid grievance, it is stated that Sh. Kalbande has been suitably informed several times on above matters by the Regional Director, FSI, CZ, Nagpur. Enclosed copies of letter No.E-417-06/239 dated 12.07.2022, letter No.E-417-06/967 dated 27.01.2023, letter No. 484-2019/1076 dated 23.02.2023 are self explanatory. He has also received the copy of transfer order and relieving order from the Regional Director, FSI, EZ, Kolkata through RT1, vide their letter No. File No.R-28/2007-Vol-111-05 dated 01.02.2023 (copy enclosed).



As per above mentioned subject, this is to inform you that my court dates are scheduled on the same day when Inquiry Officer proposed inquiry dates in 1st November 2023. IO has instructed us DE will be in October, 2023 so i arranged court proceedings accordingly. Moreover, you have been requested time & again regarding subsequent allowances to attend the inquiries. The same has been requested to IO but it was ignored to person with benchmark Locomotor disbaility.

Further, in your letter you assured that Disability Friendly atmosphere will be provided at the office of RD,FSI,CZ,Nagpur. The Disbaility Tollet is not functional, disbaility parking in not given and various obstructions are created to Divyang person which may impact to mishaps. Same has been communicated to Grivance Rederresal Officer but he denied the rights to Divyang Person.

In your letter, you strictly said no for video recordings but I have been recorded by RD,PSI,Nagpur. Previous to this hearing, there was no camera's installed to office. This is clearly violations of your instructions. I have objection for video recordings inside the hearing room. The same has been reported to IO. I will bring my camera to do video recording for departmental proceedings if my video recordings did not stop during further hearings.

I have also submitted to you before and IO during inquiry that I do not have faith in Inquiry officer, but inquiries are continued by same IO even after that.

The cross examination of second government witness is in progress, without finishing it IO has requested DFO, Wardha who's witness has already been done for DE proceedings.

Further, the office will be cancelling tresspassing for DE days. In this DE days, I will be going to section such as Store, Library, Forest Cover Mapping, Dispatch in order to handover charges of Store Library FCM which is still with me. It is surprising that Watchman is keeping the entrance locked to government office which is against service rules or any rules without any office order or notification in writing.

With regard to the above cited grievance, the reply is as under:

i). Medical reiumbursement claim.

Your medical reimbursement claim for Rs. 116942/- for Covid hospitalization could not be paid to you due to paucity of funds. As you have been transferred to FSI, EZ, Kolkata, your pending medical claim was forwarded to FSI. EZ, Kolkata for further action vide this office letter No.47/85/Medical/930 dated 11.03.2022 (copy is enclosed).

ii) Your application for NPS advance.

You had submitted a letter dated 02.03.2021 requesting for 25% advance from NPS (New Pension Scheme) fund. However, as you have not submitted the application in proper format FORM 601 PW (copy enclosed) for drawal of NPS advance along with your letter dated 02.03.2021, action could not be taken on it. Since you are already relieved from this office on 30.07.2021, you should submit the application in proper format to the Regional Director, FSI. ER, Kolkata for further action.

iii) Nil leave present as on 01.01.2021.

You were often unauthorizedly absent from duty during the year 2019 & 2020. You were also unauthorizedly absent from duty since 04.12.2020 to till your transfer from this office on 30.07.2021 (except on 12.03.2021 you have attended the Inquiry). Due to above reason.
