

A brief history of the organisation and details of different technical cadres of Forest Survey of India (FSI) are given as follows for your kind information:

I- Brief History of Forest Survey of India:-

Forest Survey of India is a premier national organisation under ministry of Environment Forest and climate change is dedicated for forest resource assessment of the country on a regular basis since 1981. The organisation came into being in 1965 as pre investment of forest resources (PISFR) on a project mode jointly by Govt. of India, FAO and UNDP. On the recommendation of National commission of agriculture in 1976, the PISFR was renamed as Forest survey of India in 1981 and made as government organisation under ministry of environment and forests. The FSI was given a revised mandate in 1986. As per the revised mandate, FSI has to carried out the Forest cover mapping of the country using satellite data on a biennially bases, inventory of forest/ tree outside forest, assisting state forest department and taking projects of national and subnational importance.

The two major task of the organisation viz. forest cover mapping using satellite data and inventory of forest and TOF are very technical work. For forest cover
