I, Dandugula Ramgopal S/o Chinna Jangalah, R/o Tirmalapur B.K, Amrabad Mandal, Nagar Kurnool District would like to appeal with you that, on 22/6/2018 two tractors and 171 acres of land belonging to 40 farmers was occupied by the Forest Officials. When it was appealed with the State, Central Government and NHRC, the NHRC Member Taloj Achary, Member of NHRC, and Forest Conservator Shobha, President of India, PMO and when the officials were asked to survey Yerpulamma Chenu, Tunigani Penta Chenu, Marrimaduga Chenu, Jillala Penta Chenu, but even after (8) eight months have passed, but the survey was not done.

In the above matter, because of the pressure from the State, Central Government and also as went around to the offices and enquired through phone also and made an application; and the directionless officials came for survey on 10/3/2022, but without coming on the site of the farmers lands has returned and again we requested them to come on the site and conduct GPS Reading, ^{Sate llite} Short-Light, ISRO Survey; but the officials did not care us and returned. They came at "Odukuntapade Vagu" and talked there and informed that through Computer, or Short Light, ISRO we will check on the Computer and told to the farmers to plough their lands and sow the crops and do cultivation and also told that they will give Order copy and left.

ON 22/6/2018 two tractors and lands of Dandugula Ramgopal were taken and as I have not signed on the white paper and I was deliberately implicated in different false cases and the Forest Officers took my father to the Forest Office in Amrabad and did not even serve him food since morning till evening and subjected to sufferings and even lost his dignity. After taking 2 tractors, and land and again on 27/1/2019 has attacked on the house and in the presence of about 200 villagers and took 12 ^{Thulalu} Tolas of Gold, 50 ^{Thulalu} Tolas of Silver and Rs.50,000/- cash and ^{Frage} Neem flowers 5 Kgs and did not even deposited in the Court neither case was filed. After the verification my father thought that on 10/3/2022 the Forest Officers will come and will return our lands and (2) two tractors and felt happy; but the Forest Officers did not visit our site and did not make any kind of GPS reading, short light Map was not shown to anybody, but returned in the middle.

Even all the farmers has consoled my father, but after 5 minutes he lost consciousness and Ambulance was called and was taken to Hospital in Amrabad and as he was serious was referred to Government Hospital Achampet, and from there they referred to Nagar Kurnool Hospital and later to Mahabubnagar Hospital. After taking treatment for two-three days on 15/3/2020 returned to his home at Tirmalapur (BK) and died in the morning at 9.55 AM.

As the Forest Department and Revenue Department has done manipulations and made the legal land as illegal land. The land was actually being cultivated since 85 years and in connivance with the Revenue department it was told that there is no land of farmers and due to psychological pressure Dandugula Chinna Jangalah i.e. my father has lost his life.

Till date the State, Central Government and Nagar Kurnool District Authorities could not do justice to us. It is humble request that the State, Central Government Officials may directly come to our village and visit the site and do justice to us. As the Yerplulamma Chenu farmers are subjected to psychological sufferings, due to which Chinna Jangaiah has lost his life and in future other farmers may also be also be

subjected to psychological sufferings and they may meet the same fate like Chinna Jangaiah. Hence, I humbly request the officials to conduct the survey and settle the matter.

1. In the year 1980 ^{satellite} Short Light ISRO Amrabad Mandal Forest Map Beats was taken and the original Map was being changed to implicate Dandugula Ramgopal i.e. Yerupulamma Chenu Beat 192 Tirmalapur (BK) Beat. The Map which was taken 42 years ago (Short Light GPS Reading) has changed as illegal Map by the Forest Department according to their convenience and the farmers of Tirmalapur (BK) were subjected to sufferings.

The Hon'ble Supreme Court has instructed to give Revenue Pattas for the lands held by three generations after passing (75) years. The lands which are being cultivated before 2005 shall not be taken by the Forest Department, this was also told by the State Government.

The Forest Officials even after having knowledge about the subject matter, with ill intention has took 170 acres of land which was being cultivated by the generations since 85 years and also 2 tractors were taken and I was implicated in illegal cases as I did not sign on the blank white paper and subjecting me to sufferings.

Further, there is life threat to me and to my family members.

Therefore, humbly request you to conduct re-survey of the Yerupulamma Chenu lands and do justice to the farmers of Tirmalapur village (BK).


