Sir,


This is in reference to the meeting of Regional Directors held on 23.01.2015 at head Quarter wherein it was decided to evolve a mechanism for regular checking of field inventory work of forest inventory and TOF by the zonal and HQ officers in prescribed format to ensure quality of field data. The compulsory checking between at different level of officers for every month, the same is given below:

- (i) 20 plots by STA and Assistant Director.
- (ii) 15 plots by Dy. Director.
- (iii) 10 plots by Regional Director.
- (iv) 5 plots by HQ officers.

The plots are to be checked in such a way that at least two plots of each crew are to be checked by STA, Assistant Director, Dy. Director and Regional Director. The higher level officer may check already inspected plots if they feel so. The field inspection report has to be submitted to HQ in prescribed every month. The format is enclosed herewith. The above scheme is implemented with immediate effect.
